RE: ONGOING RETALIATION, OBSTRUCTION OF JUSTICE AND INTERFERENCE WITH U.S. SUPREME COURT LITIGATION AND FEDERAL BANKRUPTCY PROCEEDING IN CONNECTION WITH DESTRUCTION OF FEDERALLY FUNDED ENERGY PROJECT CRIMINAL COMPLAINTS NOVEMBER 22ND, 2014, AND SUBSEQUENT COMPLAINTS.

DEAR DIRECTOR COMEY,

IN MY NOVEMBER 22ND, 2014, LETTERS TO YOU AND MS. LOUIS CALDWELL, I COMPLAINED THAT TRAVIS COUNTY 299TH DISTRICT JUDGE KARIEN SAGE, MAY HAVE BEEN BRIBED FOR DECISIONS IN MY STATE CASE.

THOSE DECISIONS DIRECTLY AFFECT MY FEDERAL CASES INVOLVING YOUR OFFICE.

CURRENTLY, THERE ARE TWO MOTIONS TO DISQUALIFY THE TRIAL JUDGE AND A REQUEST FOR ASSISTANCE LETTER TO THE REGIONAL ADMINISTRATIVE LAW JUDGE, FILED IN THE TEXAS THIRD COURT OF APPEALS, ~~THE~~ CASE NO. 03-13-0723 U2, AND A WRIT OF MANDAMUS, CASE NO.

WIC-82,475-03, FILED IN THE COURT OF CRIMINAL APPEALS OF TEXAS, TO DISQUALIFY THE TRIAL JUDGE.

RECENTLY, INFORMATION THAT PERSONS OF

CONTROVERSY IN THE DESTRUCTION OF THE JONESTOWN WIND PROJECT AND THE POSSIBLE BRIBERY OF SAGE MAY HAVE ENGAGED IN CRIMINAL FRAUD IN U.S. BANKRUPTCY COURT AND HAVE COMPLICITY IN THE DESTRUCTION OF THE PROJECT.

YESTERDAY, I WAS SUBJECTED TO MORE ON-GOING GOVERNMENT RETALIATION. THE WALLACE PACK UNIT, LAW LIBRARY COORDINATOR, J.D. SEIGLE, WITH THE HELP OF SGT. MATHIS, CAME AND INTERRUPTED MY WORKING ON MY COMPLAINTS TO YOU AND THE COURTS AND MY U.S. SUPREME COURT RESPONSE, DUE IN LESS THAN 60 DAYS FROM NOV 9TH AND INVOLVES YOUR OFFICE IN THE RUSSIAN SPY INCIDENT. SEIGLE ILLEGALLY SEIZED 4 BAGS OF MY CASE WORK. THIS OBSTRUCTION OF JUSTICE AND RETALIATION WAS PROTESTED IN FRONT OF A ROOM FULL OF PEOPLE FOR OVER 1/2 HOUR WITH REPETITIVE ARGUMENTS THAT MY ACTIVELY WORKING ON MY CASES IS STATUTORILY AND CONSTITUTIONALLY PROTECTED. REPETITIVE REQUESTS TO GET THE WARDEN WERE REFUSED. INSTEAD I WAS THREATENED WITH DISCIPLINARY ACTION.

AS SUCH, I AM SENDING YOU LIMITED DOCUMENTATION GIVING MORE DETAIL INTO THIS COMPLAINT.

REGARDING THE BANKRUPTCY COURT, THE DESTRUCTION OF THE WINDMILLS OCCURED ON PROPERTY THAT WAS UNDER FEDERAL BANKRUPTCY PROTECTION AT THE TIME. CASE NO. 09-[REDACTED]13228 (WESTERN DISTRICT

OF TEXAS), THE PROPERTY WHERE 3 WINDMILLS WERE SABOTAGED WAS OWNED BY JOHN P. "RICK" VANDERSUKE. MILTON ALLEN IS A FRIEND OF VANDERSUKE.

PAUL ALLEN, MILTON'S SON, WAS THE CARSTAKER OF THE PROPERTY. PAUL ALLEN ADMITTED TO JONESTOWN OFFICIALS HE KNEW THE PERPETRATORS.

VANDERSUKE AND THE ALLEN'S ARE VERY CLOSE FRIENDS WITH JONESTOWN MAYOR, DEANE ARMSTRONG. ARMSTRONG IS CONTROVERSY IN THE STATE CRIMINAL CASE BECAUSE SHE WAS NEVER CHARGED, HER NAME IS ALL OVER THE GRANT AND HER LOCAL POLITICAL CONNECTIONS.

ARMSTRONG, ALLEN(S), AND VANDERSUKE ARE ALL CONTROVERSY IN THE POSSIBLE BRIBING OF SAGE.

ALL HAD/HAVE MOTIVE, MEANS, AND OPPORTUNITY TO INFLUENCE HER DIRECTLY OR INDIRECTLY.
